



## History of PS Government Degree College

The Government Degree College, Penukonda, a historical place (Second Capital of Srikrishnadevaraya of Vijayanagara Dynasty) in the Anantapur district of Andhra Pradesh was established in 1980 with the objective to bring social change and development through education in this backward Rayalaseema region. From the time of its inception to the year 2003, the college has shared the accommodation with Govt. Junior College and shifted to its own building in a land admeasuring nearly 24 acres with a beautiful landscape surrounded by hills and fields on the outskirts of Penukonda town. Sri.A.Ramappa was the founder Principal of the college. In due course, the college was named after the bereaved local popular leader Late Sri. Paritala Sriramulu. The College is affiliated to S. K. University and is recognized by the UGC under its sections 2f and 12B in November 1994. At present this college location comes under Sri Satyasai District wef 4 April, 2022 (Gazette notification No 150 issue -599 dt. 13 April, 2022).

ORDER

Government have received a number of requests for the opening of new Government Degree Colleges although there is no provision in the Plan for the opening of such colleges. However, since in a number of these cases local people are willing to donate the necessary funds, Government have decided to sanction the starting of Government Degree Colleges in places where the requisite donations are forthcoming.

Government accordingly sanction the starting of a Government Degree College at Penukonda, Anantapur District during 1980-1981, subject to the fulfilment of the following conditions.

- i) The College Committee concerned should credit into Government account an amount of Rs. 2.00 lakhs (Rupees two lakhs only) immediately i.e., before the starting of the college;
- ii) That out of the amount so deposited 50 percent shall be utilised towards recurring expenditure for the current year and the balance amount available with the Government will be utilised towards the building programme;
- iii) That the college committee should provide temporary accommodation immediately for locating the college and also 25 acres of land for construction of permanent buildings in future;
- iv) The college committee should provide furniture equipment and books required for the college, as indented by the Principal immediately;

- v) The college should start with 1st year (group) B.A., and B.Com., one of the three optional subjects shall be a restructured course as approved by the University; and
- vi) Telugu should be the medium of instruction English medium also can be had provided there is the minimum strength of students prescribed by the Government.

3. The amount of Rs. 2.00 lakhs referred to in para (2) (a) above shall be credited into the Government account under the head of account "077 - Education - E.University and other Higher Education - M.H. 15 - Other receipts - S.H. (01) - Contributions and income from Endowments (to be opened)"



The Revenue Inspector, Penukonda, has submitted transfer proposals after observing all the formalities for transfer of the above lands from Assessed Waste to Government Degree College Peramboke, Penukonda.

All Notice has been published in the village and no objections have been received.

I have inspected the above lands on 7x 7-11-85. All the above lands were assigned under G.O. 1142 and were subsequently resumed to Government in this Office RC. 954/81(A2) Dt. 10.9.81 for transfer to Government Degree College, Peramboke, Penukonda. All the above lands are Assessed Waste and are now waste except in S.No. 980-4 wherein groundnut in an extent of 1-00 acre has been raised by Ramaji Naick s/o Subbe Naick of Mangapuram h/o Penukonda. He is having land of 5-00 acres in Kegira village. It will be harvested by the end of this month. The above lands are situated towards North-West to Penukonda town abutting to Country Road leading to Kenapuram from Penukonda town and they are about 1 1/2 Kms away from Penukonda. The above lands are convenient and suitable for construction of buildings for the Degree College and play grounds. There are no other suitable lands in the vicinity for the purpose

I there-fore recommend that the above lands measuring 23-85 Acres of Penukonda Town (Assessed Waste lands) may be transferred to Government Degree College Peramboke, Penukonda for construction of buildings for Government Degree College and for play ground at Penukonda and I may be permitted to hand-over possession of the above lands to Principal, Government Degree College, Penukonda.




